4.End use: The material must not be sold or distributed; for research or analysis only.

5.Containment: The material must be routed directly to the approved facility. The material must be packaged and transported in sturdy, leak-proof containers. The material must be contained until processed.

6.Traceability: At all times (i.e. during importation, research or analysis, storage and until disposal), the material must be identified with labels or other effective identification means. The importer must keep a log book of all importations. This log book must show where the material is in the facility, its status (e.g. treated, stored), and the number of the Permit to Import under which the material was imported.

7.Records: A list of the plant material (genus, type of plant material [e.g. leaves], and origin) imported in each consignment must be maintained and made available to the CFIA for review on request.

8.Propagation: The material must not be propagated.

9.Isolation: Research or analysis must be conducted in a laboratory or greenhouse where quarantine isolation from living plants and the outdoor environment is maintained.

10.Disposal: Any residual material must be: treated in a dry oven at 121°C for a minimum of 6 hours; or be autoclaved at 15 pounds per square inch (psi) pressure at 121°C for a minimum of 30 minutes (45 minutes for fruits and vegetables between 2.5 and 20 cm in diameter); or be sterilized or disposed of by another method previously approved by the CFIA.

11.Movement: A CFIA Movement Certificate is required in order to move the material to another research or analysis facility.
